(ii) In the case of the Income and Expenditure Account, of the Deficit of Expenditure over income of the Political Party for the year ended on that date, and

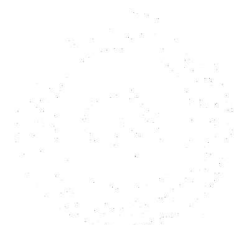
(iii) In the case of Cash Flow Statement, of the cash flows for the year ended on that date.

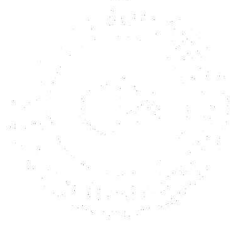

1. BASIS OF PREPARATION OF FINANCIAL STATEMENTS

The financial statements have been prepared under the historical cost convention, on the accrual basis of accounting and in accordance with the fundamental accounting assumptions, viz Going Concern, Consistency and Accrual.

2. RECOGNITION OF INCOME AND EXPENDITURE

These accounts have been prepared under the historical cost convention on the basis of a going concern with revenues recognised and expenses accounted on their accrual including provisions/adjustments for obligations and amounts determined as payable or receivable during the year.

NOTES ON THE BALANCE SHEET AND INCOME AND EXPENDITURE ACCOUNT

1. The Political Party keeps and maintains a record of each voluntary contribution in excess of Rs. 20,000/- the names and address of person who have made such contribution, mode of payment and details of financial instrument and PAN numbers where applicable.
2. During the year the Political Party have received nil donation through Electoral Bonds.
3. Taking into consideration Section 13A of the Income Tax Act, 1961, the income tax liability of the financial year 2019-20 relevant to the assessment year 2020-21 has not been ascertained and hence, no provision for tax has been made in the financial year 2019-20.
4. Expenditure in Foreign Currency is nil and earnings in Foreign Exchange is also nil.
5. The Financial Statements, i.e., the Balance Sheet, Income & Expenditure Account, Cash Flow Statement and Receipts & Payments Account have been prepared pursuant to guidance note on accounting and auditing of a Political Parties issued by the Institute of Chartered Accountants of India, New Delhi.
