1. BASIS OF PREPARATION OF FINANCIAL STATEMENTS

The financial statements have been prepared under the historical cost convention, on the accrual basis of accounting and in accordance with the fundamental accounting assumptions, viz Going Concern, Consistency and Accrual.

2. RECOGNITION OF INCOME AND EXPENDITURE

- 2. During the year the Political Party have received nil donation through Electoral Bonds.
- 3. Taking into consideration Section 13A of the Income Tax Act, 1961, the income tax liability of the financial year 2021-22 relevant to the assessment year 2022-23 is nil. Hence, no provision for tax has been made in the financial year 2021-22.
- 4. Expenditure in Foreign Currency is nil and earnings in Foreign Exchange is also nil.
- 5.
